All that lot of land situate on the West side of Mayfair Lane, in Butler Township, in Greenville County, State of South Carolina, shown as Lot 17 on plat of Holmes Acres, made by Dalton & Neves, Engineers, February 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Z", at page 1, and having, according to said plat, the following metes and bounds, to-wit:
