W. B. Greer and his heirs and assigns:

All that certain parcel or lot of land containing Two (2) Acres, more or less, situated on the west side of the Rutherford Road near Jubilee Church, about four miles north from Taylors, in Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 2 of the D. F. Greer Estate, according to survey and plat thereof by H. S. Brockman, Surveyor, dated November 20, 1950, and having the following courses and distances, to wit: Beginning at a point in the Rutherford Road, corner of Lot No. 1; and running thence along the line of Lot No. 1, N. 47.45 W. 792 feet to stake on line of Lot No. 7; thence along the line of Lot No. 7, N. 42.00 E. 110 feet to stake, corner of Lot No. 3; thence along the line of Lot No. 3, S. 47.45 E. 792 feet to stake on south east side of Rutherford Road; thence along said road, S. 42.00 W. 110 feet to the beginning corner.
