in consideration of the sum of Four Hundred Sixty-Five and No 10/100 (.465.00) - - - DOLLARS.

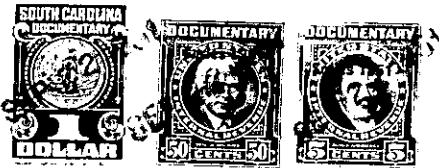
