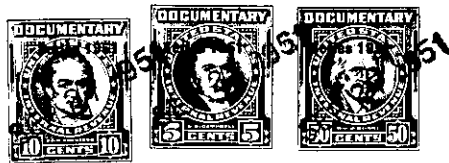
That I, L. Gertrude Hudson Waldrop, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joe Rector, his heirs and assigns: All those pieces, parcels or lots of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 36 and 37, Hudson Acres, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Y, page 39, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Hudson Drive joint front corner of Lots Nos. 35 and 36, said iron pin being 785.2 feet in a Southeasterly direction from an iron pin in the Southeast intersection of Old Spartanburg Road and Hudson Drive and running thence S. 82-40 E. 368.6 feet to an iron pin joint rear corner of Lots Nos. 35 and 36; thence N. 4-45 W. 357.8 feet to an iron pin joint rear corner of Lots Nos. 37 and 38; thence N. 82-40 W. 291 feet to an iron pin on the Easterly side of Hudson Drive; thence along the Easterly side of Hudson Drive, S. 7-20 W. 350 feet to an iron pin, the point of beginning.
