ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, being shown and designated as lot No. 4 on Plat of Property of King Greer Estate (North Tract), said Plat made by J. Earl Freeman, Surveyor, March 1938, being bounded on the northern side by lands of Mrs. Sloan Black, on the eastern side by lands of John Dill, on the southern side by lot No. 1, and on the western side by lot No. 3, and having the following courses and distances, to wit:-
