in consideration of the sum of Four Hundred Ninety-five & 00/100-----(\$495.00)----- DOLLARS,

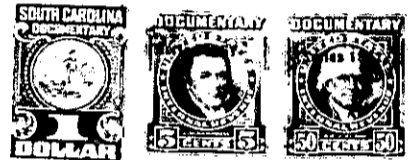

Rector and Ila Mae Rector, their heirs and assigns;

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 115 of a subdivision known as Section "A", of Englewood Estates, as shown by a Plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville, South Carolina, in Plat Book Y at Page 140, and having the following metes and bounds to-wit:

BEGINNING at an iron pin joint corners of Lots No. 115 and 113 and running thence with the line of Lot No. 113, S. 2-30 W. 200 feet to an iron pin at back corner of Lot No. 114; thence with the line of Lot No. 114 S. 87-30 E. 100 feet to iron pin on Overbrook Drive; thence along Overbrook Drive N. 2-30 E. 175 feet to an iron pin; thence in a curve in a northwesternly direction along the intersection of Overbrook Drive and Woodbine Drive 34.6 feet to an iron pin; thence along Woodbine Drive N. 87-30 W. 75 feet to point of beginning.

THIS deed is made subject to the following restrictions:

1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.
