Less, however, a strip of approximately  $8\frac{1}{2}$  feet conveyed to the City of Greenville, for widening of Faris Road, by deed recorded in Book of Deeds 440 at Page 416. As a part of the consideration for this deed the grantee assumes and agrees to pay a balance of 39,190.84 due on a mortgage executed by the Grantor to Liberty Life Insurance Company recorded in Book of Mortgages 384 at Page 420.
