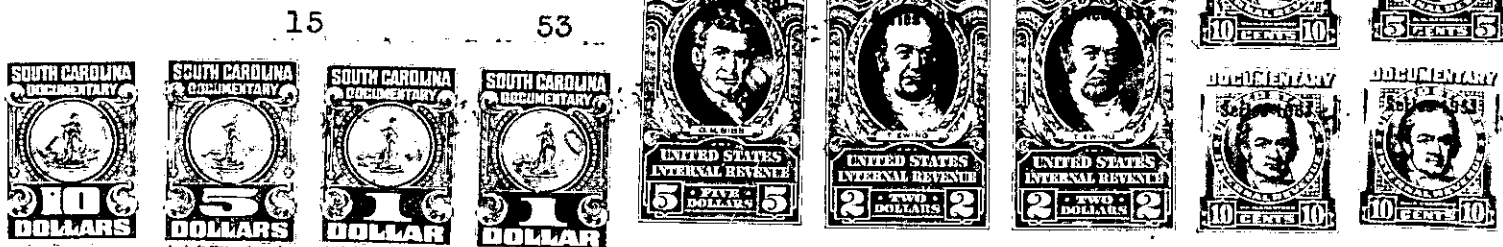


THE STATE OF SOUTH CAROLINA,

KNOW ALL MEN BY THESE PRESENTS, That I, Ben F. Perry, of the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars (\$10.00) and other valuable considerations, to me in hand paid at and before the sealing of these presents by J. B. Quinn, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. B. Quinn,

all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Merrilat Avenue between Parkside Avenue and Callahan Avenue, in Mansfield Heights, a sub-division situate on the east side of the road about four miles north of the City of Greenville, said lot having the following lines, courses and distances:-

beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Merrilat Avenue, said pin being the joint front corner of lots numbered seventy-five (75) and seventy-six (76); thence with the eastern line of lot seventy-five (75); S. 33-12 E., ninety-five and eight tenths (95.8) feet, to an iron pin, rear corner of lots seventy-five (75) and seventy-six (76); thence along the rear line of lot sixty-six (66), S. 59-12 E., seventy-five (75) feet, to an iron pin, rear corner of lots seventy-six (76); thence along the rear lines of lots fifty-four (54) and fifty-five (55), S. 35-13 E., ninety-five (95) feet, to an iron pin on the northern edge of said sidewalk running along Merrilat Avenue, joint corner of lots fifty-four (54) and seventy-six (76); thence along the northern line of said sidewalk, S. 59-12 E., eighty (80) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered seventy-six (76), on plat of said property recorded in the office of the Register of Deeds and Conveyance for Greenville County in Plat Book "W" at page 157, which plat is hereby referred to and made a part hereof.

This property is sold subject to the restrictive covenants applicable to Mansfield Heights, recommended by the Federal Housing Administration, and recorded by the owner in the office for Greenville County in Book 25 at page 500, and the same is hereby referred to and made a part hereof.

The above described land is a part of the same conveyed to me by Frances T. Lindal, et al., and J. Inman, Master, on the third day of January, 1950, deed recorded in office Register of Mesne Conveyance for Greenville County, in Book 399 Pages 236 and 215.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the said J. B. Quinn, his Heirs and Assigns forever.
