(3) ALSO that other tract of land in the Township, County and State aforesaid, on branch waters of Mush Creek, South Tyger River, and is a part of a tract of land of Robert Pitman, Sr., known as Tract No. 4, and runs as follows:

BEGINNING on a stone 3x on Henry Pitman's line and runs thence S. $76\frac{1}{2}$ W. 10.85 chs. to a WO 3x in the branch on a rock shoal now gone; thence North to a stone corner near Robert Pitman's spring on the said D.W. Pitman's line, and is also a corner of Robert and Al Pitman's; thence S. 65 E. 12.40 to stone 3x on Tract No. 3 line W. C. Pitman; thence with said line S.11.00 chs. to beginning corner, containing 11 3/4 acres, and bounded on the south by Henry Pitman land, west by Sarah A. Pitman (No. 8) on nh. by Tract No. 5, east by Tract No. 3. ALSO that other tract of land in the Township, County and State aforesaid on a branch of Mush Creek, waters of South Tyger River, being part of the Robert Pitman Tract, and described as follows:

BEGINNING on a W. O. 3x in a branch shoal of rocks and runs thence N. 46 W. 9.00 chs. to a stone 3x, also a corner of Robert Pitman's; thence N. 20 E. 14.20 chs. to a stone 3x; thence with No. 5 line (Robert's) to a stone 3x No. 4 corner; and thence with line of No. 4 Tract to the beginning W. O. 3x, containing 11 3/4 acres, more or less, and bounded on the SW by Luther and Riley Pitman, on northwest by Robert (No. 5); by Tract No. 4 on the east.

The within two tracts of the Pitman land, containing 11 3/4 acres each, were conveyed to us by J. C. Roe, et al, by deed dated December 23, 1946, and recorded in the R. M. C. Office for Greenville County in Book 306, page 87.

(4) ALSO that other tract of land in the Township, County and State aforesaid, containing 50 acres, more or less, bounded on the north by lands now or formerly of Rufus Allen, on the east by J. J. McSwain, on the south by Burrel Cox, and on the west by lands of Tifton, and being the same owned by Mrs. Louisa Phillips Griffin at the time of her death. The above described tract of land was conveyed to Oscar Barton and G. J. Barton by E. Inman, Master for Greenville County, by deed dated November 21, 1925, and recorded in Book 67, page 174. Oscar Barton died intestate on the day of March, 1939, leaving as his sole heirs at law and distributees, his wife, Tessie Barton, and his three children, Pearl B. Johnson, Eula B. Bishop and G. J. Barton, and the said 50-acre tract was conveyed to us by the said Tessie Barton, Pearl B. Johnson, Eula B. Bishop and G. J. Barton by deed dated September 7, 1946, and recorded in Book 298, page 330.

(5) ALSO that other tract of land in the Township, County and State aforesaid, described as follows:

BEGINNING at a Chestnut stump near Beason place; thence North to a stone corner in Mill Creek; thence up said creek to a stone corner in the creek; thence north to Henry Pitman's stone corner; thence along Henry Pitman's line North to bend in the road on stone corner; thence along the road North to J. H. Roe's stone corner; thence southwest along Roe's line to a rock shoals corner on White Oak in branch; thence along the branch South to the Creek; thence northwest along the creek to J. P.
