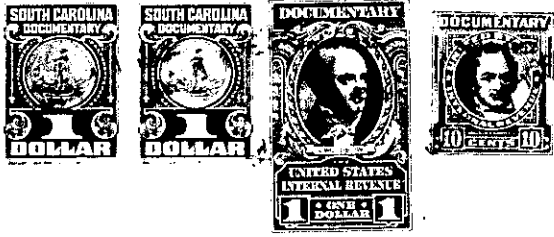
Know All Men by These Presents:

BEGINNING at an iron pin on Green Street, joint corner of Lots Nos. 1 and 2 and thence running along the east side of Green Street S. 19-30 W. 80 feet to an iron pin; thence S. 70-30 E. 147.7 feet to an iron pin at the corner of Lot No. 3; thence along the joint line of that lot N. 19-30 E. 80 feet to the rear corner of Lot No. 2; thence with the joint line of that lot H. 70-30 W. 147.7 feet to the beginning corner on Green Street.
