(1) BEGINNING at a pin on the Northwest intersecting corner of Birnie Street and Whitt's Alley and running thence with the Western side of Whitt's Alley N $28\frac{1}{2}$ E 165 feet to a pin, corner of other property of grantees; thence with line of grantees N $61\frac{1}{2}$ W $57\frac{1}{2}$ feet to a pin in line of lot No. 20, according to plat recorded in the office of Register of Mesne Conveyance in and for Greenville County, South Carolina in Deed Book LL at Page 61; thence with line of said lot No. 20 S $28\frac{1}{2}$ W 165 feet to a pin on the North side of Birnie Street; thence with the North side of Birnie Street S $61\frac{1}{2}$ E $57\frac{1}{2}$ feet to the point of beginning, and containing 9487 sq. ft., more or less, and being the same property conveyed to W. M. Norwood by deed of W. H. Whitt, dated July 1, 1912, recorded in aforesaid Register's Office in Deed Book 19, Page 430.

(2) BEGINNING at a pin on the South side of Whitt's Alley, Globe Realty Company line, and running thence with line of said Globe Realty Company S $61\frac{1}{2}$ E 58.3 feet, more or less; thence N $28\frac{1}{2}$ E 67.5 feet to a pin; thence in a Southeastern direction 93 feet to a pin on right-of-way of Southern Railway; thence with Southern Railway's right-of-way N $61\frac{1}{2}$ W 93 feet, more or less, to a pin on the South side of Whitt's Alley; thence S $28\frac{1}{2}$ W 171 feet to the point of beginning and containing 9832 sq. ft., more or less, and being the same property conveyed to W. M. Norwood by W. H. Whitt by deed dated July 1, 1912 and recorded in the office of said Register in Deed Book 19 at Page 431.
