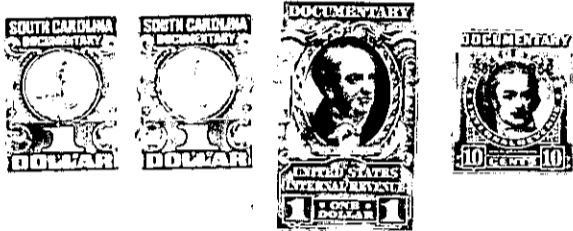
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Analane C. Gibson, her heirs and assigns, all that piece, parcel or lots of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 1, 2, 3, and 4, Block C, Stone Estates, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 3, page 292, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southerly side of Legare Street, joint front corner Lots Nos. 4 and 5, Block C, Stone Estates, and running thence in a Southerly direction 190.4 feet to an iron pin, joint rear corner Lots Nos. 4 and 5; thence S. 52-30 E. 58.4 feet to an iron pin; thence in a Northerly direction 190 feet to an iron pin on the Southerly side of Legare Street; thence along the Southerly side of Legare Street N. 52-30 E. 98.6 feet to an iron pin, the point of beginning.
