All that piece, parcel or lot of land in the city and county of Greenville, state of South Carolina, known and designated as lot number thirty-eight (38) on plat of Carver Park made by Piedmont Engineering Service, October 1951, and recorded in the R. M. C. Office for Greenville County in plat book "AA", page 187, and having according to said plat the following courses and distances, to-wit:

Beginning at an iron pin on the south side of Gandy Street, joint front corner of lots 38 & 39, and running thence with the joint line of said lots S. 19-46 E. 122.9 feet to an iron pin in the rear line of lot No. 36; thence with the line of lots 36 & 37, N. 89-41 W. 88 feet to an iron pin; thence N. 0-19 E. 110 feet to an iron pin on Gandy Street; thence with Gandy Street N. 75-25 E. 46 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R. M. C. Office for Greenville County in deed book 444, page 498, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said R. M. C. Office in deed book 445, page 235.

The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine by deed dated March 10, 1951, and recorded in the R. M. C. Office for Greenville County in deed book 430, page 372.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anyway incident or appertaining

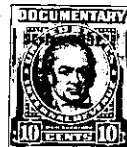
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
