in consideration of the sum of Eighteen Hundred and No/100- - - - - (\$1800.00) DOLLARS,

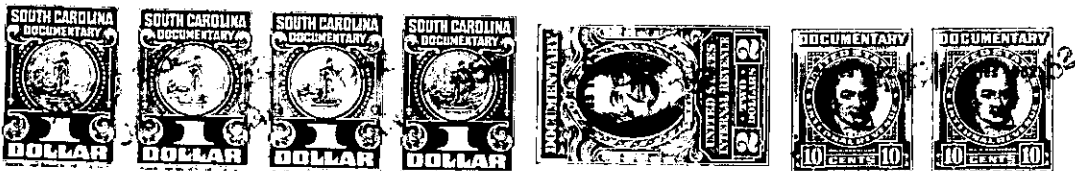
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gladys B. Austin, her Heirs and assigns forever,

All those two certain lots of land in Chick Springs Township, Greenville County, State of South Carolina, lying on the Northwestern side of Mabel Avenue, being shown as Lots Nos. 255 and 256 on Plat of the property of Robert J. Edwards, made by Dalton & Neves in May 1951, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Mabel Avenue at the joint front corner of Lots Nos. 254 and 255, and running thence with the line of Lot No. 254, N. 47 W. 200 feet to an iron pin at the rear corner of Lot No. 272; thence with the rear line of Lots Nos. 202 and 201, S. 43 W. 200 feet to an iron pin at the rear corner of Lot No. 257; thence with the line of Lot No. 257, S. 47 E. 200 feet to an iron pin on Mabel Avenue; thence with the Northwestern side of Mabel Avenue, N. 43 E. 200 feet to the point of beginning.

It is understood that this conveyance is made subject to the following restrictions which are expressly made a part of the consideration therefor:

- (1) This prop rty shall be used expressly for residential purposes.
- (2) No dwelling shall be built thereon to cost less than \$10,000.00, nor containing less than 1200 square feet of floor space, exclusive of porches and breezeways.
- (3) No dwelling shall be constructed thereon out of concrete block.
