

B. Milton, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being on the Southern side of Bradley Boulevard, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 61, on plat of University Park, by Dalton & Neves, dated November 1946, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 127 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Bradley Boulevard, joint front corner Lots Nos. 61 and 62 and running thence along Bradley Boulevard S. 52-26 W. 71 feet to an iron pin on the Eastern side of Stephen Lane; thence along the Eastern side of Stephen Lane S. 37-34 E. 175 feet to an iron pin, rear corner of Lot No. 61 on a 20 foot alley; thence along the Northern side of said alley N. 52-26 E. 71 feet to an iron pin, joint rear corner Lots Nos. 61 and 62; thence along the joint line of those lots N. 37-34 W. 175 feet to an iron pin on the Southern side of Bradley Boulevard, the point of beginning.
