KNOW ALL MEN BY THESE PRESENTS, That I, Ben H. Henry, of the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars (\$10.00.) and other valuable considerations, to me in hand paid at and before the sealing of these presents by Clarence S. Coleman, Jr., (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Clarence S. Coleman, Jr.,

all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Merrilat Avenue between Larnshaw Avenue and Callahan Avenue, in the Sans Souci Heights Sub-Division situate on the New Furcombe Road about four miles north of the City of Greenville, said lot having the following lines, courses and distances:-

Beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Merrilat Avenue, said pin being the joint front corner of lots numbered seventy-four (74) and seventy-three A (73-A); thence along the northern edge of said sidewalk, N. 77-38 E., ninety-one and four tenths (91.4) feet, to an iron pin, joint front corner of lots seventy-three (73) and seventy-three A (73-A); thence along the eastern line of lot seventy-three (73), N. 11-42 E., eighty-nine and two tenths (89.2) feet, to an iron pin, joint rear corner of lots seventy-three (73) and seventy-three A (73-A); thence S. 77-38 E., thirty-one and five tenths (31.5) feet, to an iron pin, joint rear corner of lots seventy-three A (73-A) and seventy-four (74); thence along the western line of lot seventy-four (74), S. 21-49 E., one hundred and seven and three tenths (107.3) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered seventy-three A (73-A) on Plat of said property recorded in Plat Book "A" at page 59, which Plat is hereby referred to and made a part hereof.

This property is sold subject to the restrictive covenants applicable to Sans Souci Heights, recommended by the Federal Housing Administration, and recorded by the Owner in the Office of the Register of Mesne Conveyance for Greenville County in Book 425 at page 500, and the same is hereby referred to and made a part hereof.
