All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, about two miles North from the City of Greer, lying on the Northside of a road that leads from Greer to Oneal and also fronting 30 feet on the North side of the Ballenger Road, bounded on the North and East by other lands of W.
