to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Earle M. Lineberger and E. M. Paul, Jr., their heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 119, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Brookside Circle at the joint front corner of Lot Nos. 118 and 119 and running thence with the joint lines of said lots S. 37-34 E. 182.5 feet to an iron pin, joint corner of Lots Nos. 95, 96, 118 and 119; thence with the line of Lot No. 95, N. 52-26 E. 75 feet to an iron pin joint corner of Lots Nos. 94, 95, 119 and 120; thence with the line of Lots Nos. 119 and 120, N. 37-34 W. 170.4 feet to an iron pin on the Southern side of Brookside Circle; thence with Brookside Circle S. 61-46 W. 76.1 feet to the beginning corner.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
