and Southern Public Utilities Company, to one or more of them and/or to others all water and sewer pipe lines (other than house lines), electric light and equipment used in connection with, or forming a part of, the water, fire protection, electric light and power gourpose of maintenance, repair, alteration, replacement and operation (including meter reading) of the lines and street trolley power lines constructed or to be constructed, and to relocate certain of such lines and systems aforesaid and of certain other apparatus records in the R. M. C. Office for Greenville County, South Carolina.

There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described and this conveyance is made subject to the rights of way and easements afore and street said lot.

This conveyance is made subject to the following restrictions:

- (1) That no mercantile establishment, other than those already in existence, shall be erected, operated or maintained on the lot S above described.
 - (2) That only one residence shall be erected or maintained on any one lot.
