All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 114 of College Heights as shown on plat to be recorded in the R. M. C. Office for Greenville County in plat book No. 75, and having according to a more recent survey made by R. M. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Auburn Circle, the point corner of lots Nos. 114 & 115, and running thence with the joint line of said lots S. 13-43 E. 149 feet to an iron pin; thence S. 76-13 E. 75 feet to an iron pin corner of lot No. 113; thence with the line of said lot S. 13-43 E. 149.1 feet to an iron pin on the south side of Auburn Circle; thence with the south side of said street N. 76-17 E. 75 feet to the point of beginning.
