That I, Donald F. Baltz in consideration of the sum of Seventy-nine Fifty (\$7950.00) in the State aforesaid, DOLLARS,

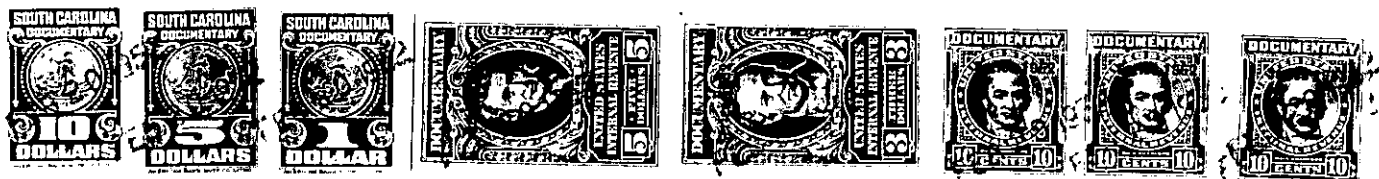

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 44 of College Heights as shown on plat thereof recorded in plat book P page 75, and having according to a more recent survey made by R. W. Dalton, February 1952 the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of Princeton Avenue, the joint corner of lots Nos. 43 & 44, and running thence with the point line of said lots N. 33-10 W. 150 feet to an iron pin; thence S. 53-50 W. 75 feet to an iron pin corner of lot No. 45; thence with the line of said lot S. 33-10 W. 150 feet to an iron pin on the northwest side of Princeton Avenue; thence with the northwest side of said Avenue N. 56-50 E. 75 feet to the point of beginning.
