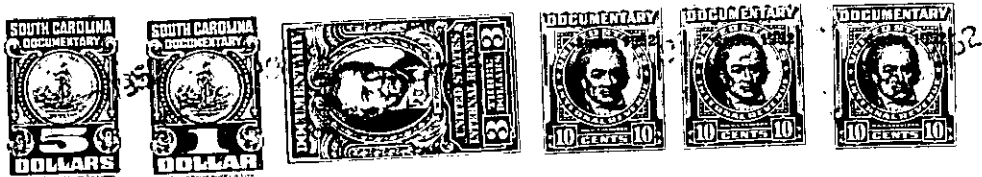

All those certain pieces, parcels or lots of land situate, lying and being on the North side of Paris Mountain Avenue near the City of Greenville, and being known and designated as Lots Numbers 11 and 12 of the property of Leo G. Ballenger according to plat made by Dalton and Neves, February 1952, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the North side of Paris Mt. Avenue, thence N. 6-13 W. 174.1 ft. to an iron pin; thence N. 84-0 E. 121 ft. to an iron pin at the rear corner of Lot Number One; thence S. 6-13 E. 173.9 ft. to an iron pin on Paris Mt. Avenue, thence along Paris Mt. Avenue S: 83-50 W. 121 ft. to an iron pin, and the beginning corner.
