in consideration of the sum of Six Hundred Fifty (\$650.00) and 00/100----- DOLLARS,

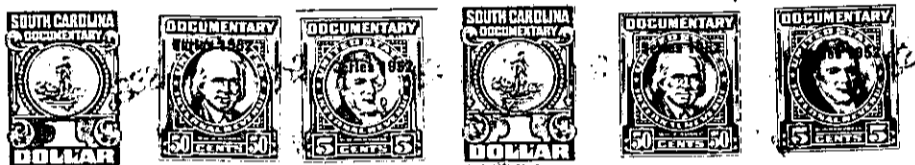

Carey, her heirs and assigns:

All that piece, parcel, or lot of land in the City of Greenville, State of South Carolina, known and designated as lot seventeen (17) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

BEGINNING at a point on Tuskegee Avenue, joint corner of lots 17 and 18 and running thence along Tuskegee Avenue N. 87-12 W. 60 feet to corner of lot 16; thence along the line of lot No. 16 N. 2-48 E. 120 feet to corner of Johnson property; thence along Johnson property S. 87-12 E. 60 feet to corner of lot No. 18; thence along the line of lot No. 18 S. 2-48 W. 120 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 444, page 498, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said R.M.C. Office in Deed Book 445, page 235.

The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine, by deed dated March 10, 1951, and recorded in the R.M.C. Office for Greenville County in Deed Book 430, page 372.
