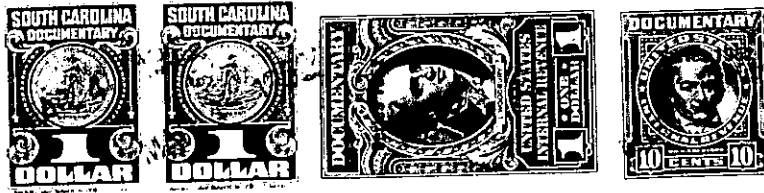

KNOW ALL MEN BY THESE PRESENTS, That More, Inc.

a corporation chartered under the laws of the State of Delaware
and having its principal place of business at
Greenville in the State of South Carolina for and in consideration
of the sum of Nine Hundred Ninety-five and no/100 (\$995.00) Dollars,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee
hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and
released, and by these presents does grant, bargain, sell and release unto
J. H. Sentell, his Heirs and Assigns:

All that certain piece, parcel or lot of land, lying and being on the Northwesterly side of Camp Road, near the City of Greenville, South Carolina, being shown as Lot No. 10 on the plat of North Meadow Heights and recorded in the R&C Office for Greenville County, S. C., in Plat Book "W", page 183, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Camp Road at a point 95 feet Southwest of the Northwesterly corner of the intersection of Camp Road and Green Meadow Lane, said pin being the joint front corner of Lots Nos. 9 and 10 and running thence along the joint line of said lots N 51-43 W 120 feet to an iron pin, joint corner of Lots Nos. 8, 9 and 10; thence along the joint line of Lots Nos. 8, 9 and 10 S 68-54 W 80.1 feet to an iron pin, joint corner of Lots Nos. 8, 10, 11 and 13; thence along the joint line of Lots Nos. 10 and 11 S 48-35 E 160 feet to an iron pin on the Northwesterly side of Camp Road; thence along the Southwesterly side of Camp Road N 41-21 E 18.4 feet to an iron pin; thence continuing along the Northwesterly side of Camp Road N 38-17 E 59.6 feet to the point of beginning.

The recorded plat above referred to indicates that this lot lies within the City Limits of Greenville, S. C. However, this line has been changed and according to the records of the Greenville County Auditor, this lot is not within the city limits.

This is part of the property conveyed to the grantor by deed recorded in Deed Book 419, page 347.
As part of the consideration hereof, this property is conveyed subject to the restrictive covenants recorded in Deed Book 439, page 409.

This deed is executed pursuant to the authority contained in a resolution duly adopted by the Board of Directors of More, Inc. on August 8, 1951.
