

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, designated as Lot #82 on a plat of Sunset Hills, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book P at page 19, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Sunset Drive, said pin being 375 feet North West of the intersection of Sunset Drive and Waccamaw Avenue, and running thence S. 48-50 W. 175 feet along Lot # 81 to an iron pin on a 5 foot utility strip; thence along said utility strip N. 41-10 W. 75 feet to an iron pin; thence N. 48-50 E. 175 feet along the line of Lot # 83 to an iron pin on Sunset Drive; thence along the Southwestern side of Sunset Drive S. 41-10 E. 75 feet to an iron pin at the point of beginning.
