Know All Men by These Presents:

That I, Daisy B. Cleveland in the State aforesaid, in consideration of the sum of Two Hundred and No/100 (\$200.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. H. Canham, his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, in Bates Township, between Jackson Avenue and Mays Avenue, but not adjoining any street, in the town of Marietta, and being shown as lot 27, on plat of property of Daisy B. Cleveland, made by W.J. Riddle, in April 1951, and described as follows:

BEGINNING at a stake 150 feet S. 47-30 W. 150 feet from Jackson Avenue, at the rear corner of lot 13, and running thence with rear lines of lots 13, 12, 11, 10 and 9, N. 46-00 W. 116 feet to a stake at corner of lot 26; thence with the line of lots 26, 25 and 24, S. 47-30 W. 75 feet to a stake at corner of lot 28; thence with line of said lot, S. 46-00 E. 116 feet to a stake; thence N. 47-30 E. 75 feet to the beginning corner.
