R.M.D. Know All Men by These Presents:

That I, Henry P. Willimon in the State aforesaid in consideration of the sum of Thirty-nine & 50/100-----(\$39.50)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Dodenhoff, his heirs and assigns forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 310 of Pine Forrest as shown by a Plat thereof, made by Madison H. Woodward, Engineer, said lot having the courses, distances, metes and bounds as are shown on said Plat.

BEGINNING at an iron pin joint corner of Lots No. 309 and 310, and running thence along the line of said Lot No. 309, S. 79-06 W. 140 feet to iron pin in line of Lot No. 313; thence along the line of said Lot No. 313, S. 10-54 E. 70 feet to iron pin at rear corner of Lot No. 311; thence along the line of said Lot No. 311, N. 79-06 E. 140 feet to iron pin on Pine Lake Circle; thence along with said Pine Lake Circle, N. 10-54 W. 70 feet to point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
