to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Glenn M. Hatfield, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville, County, State of South Carolina, being known and designated as Lot No. 40 of a subdivision known as Section "B", of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 11.

BEGINNING at an iron pin joint corners of Lots No. 39 and 40 and running thence along the line of said Lot No. 39, N. 87-30 W. 175 feet to iron pin at rear line of Lot No. 35; thence along the rear line of said Lot No. 35, N. 2-30 E. 75 feet to iron pin at back corner of Lot No. 41; thence along the line of said Lot No. 41, S. 87-30 E. 175 feet to iron pin on Buffalo Drive; thence with the said Buffalo Drive, S. 2-30 W. 75 feet to point of beginning corner.

THIS deed is made subject to the following restrictions:

1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.

GRANTEE to pay taxes for the year 1952.




TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

Witness the grantor's(s) hand and seal this 7th day of April in the year of our Lord One Thousand Nine Hundred and Fifty-two.




