Know All Men by These Presents:

That I, Walter W. Goldsmith in the State aforesaid, in consideration of the sum of Eight Hundred Fifty & 00/100-----(\$850.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Virginia R. New, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lots No. 101 and 102 of a subdivision known as Englewood Estates, Section "A", as shown by a plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville, South Carolina, in Plat Book Y at Page 140, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Evelyn Drive and running thence with the said Evelyn Drive, S. 29-20 E. 210.4 feet to iron pin on corner; thence in a curve to the southeast in an arc, the radius of which is 25 feet, to an iron pin; thence S. 87-30 E. 103.7 feet to an iron pin at front corner of Lot No. 97; thence running with the line of said Lot No. 97, N. 2-30 E. 200 feet to iron pin rear corner of Lot No. 98; thence along the rear lines of Lots No. 98, 99, and 100, N. 87-30 W. 253.1 feet to point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.
