

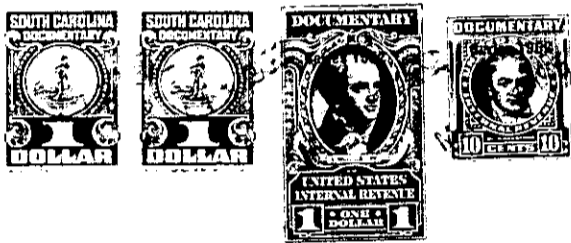

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Rosamond and H. L. Rosamond, herein called grantees, all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 13, as shown on plat of Arnold Place, prepared by Dalton & Neves, Engineers, December 1944, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book C, Page 111, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an I.P. on the southern side of Joe Lewis Avenue, joint front corner Lots 12 and 13, and running thence along Joe Lewis Ave. N. 01-0 W. 42' to an I.P., joint front corner Lots 13 and 14; thence S. 20-25 W. 130.4' to an I.P., joint rear corner Lots 13 and 14; thence S. 00-15 E. 42' to an I.P., joint rear corner Lots 12 and 13; thence N. 28-25 E. 130.0' to an I.P., the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
