That I, Analane C. Gibson in the State aforesaid, in consideration of the sum of Ten Dollars and other valuable consideration DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said SAMUEL L. WITCHER, His Heirs and Assigns:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as lot No. 6 as shown on plat of property of H. C. Gibson, prepared by Madison H. Woodward, January 1952, and described as follows:

BEGINNING at an iron pin at the Northwest intersection of E. North Street Extension, and White Oak Drive, and running thence with White Oak Drive, N. 40-37 E. 190.7 feet to an iron pin; thence S. 55-0 W. 81.2 feet to an iron pin, joint rear corner of lots 5 and 6; thence with joint line of said lots, S. 35-0 E. 190 feet to an iron pin in the Northern side of E. North Street Extension; thence with the said Street, N. 55-0 E. 100 feet to the beginning corner. Being a portion of the premises conveyed to the grantor by two deeds one recorded in Volume 450 at Page 259 and the other in Volume 450 at Page 262.

As a part of the consideration for this deed, the grantee assumes and agrees to pay a mortgage on the above described premises in the sum of \$5000.00 to the First Federal Savings & Loan Association, dated April 8, 1952, recorded in Volume 527 at Page 232.

Grantee is to pay 1952 taxes.
