Know All Men by These Presents:

That SAMUEL M. WITCHER in the State aforesaid, in consideration of the sum of TEN (\$10.00) DOLLARS AND OTHER VALUABLE CONSIDERATION DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ANALANE C. GIBSON, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the South side of Ackley Street, being shown as all of Lot 3 on Plat of Property of Rachael J. Cely, prepared by J. Coke Smith, in August, 1939, recorded in Plat Book "M", page 45, R.M.C. Office for Greenville County, S. C. and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Ackley Street, 84 feet from the corner of an unnamed street (now Celand Street) and running thence N. 65-15 E. 81 feet to an iron pin, joint corner of Lots Nos. 2 and 3; thence in a Southeasterly direction along the joint line of Lots Nos. 2 and 3, 200 feet to a point, joint corner of Lots Nos. 2, 3 and 5; thence in a Westerly direction along the line of Lot No. 5, 66 feet to a point, joint corner of Lots Nos. 3, 4 and 5; thence in a Northwesterly direction along the line of Lot No. 4, 200 feet to the point of beginning.

As part of the consideration the Grantee herein assumes and agrees to pay the balance due and owing on a certain mortgage executed by C. C. Mabe in favor of Fidelity Federal Savings and Loan Association, dated June 27, 1949, in the original sum of \$3500.00, recorded in Mortgage Book 430, page 473, said R.M.C. Office, upon which mortgage there is presently due a balance of \$ 2745.36.

This is the same property conveyed to the Grantor by deed of C. C. Mabe dated May 30, 1950, recorded in the R.M.C. Office for Greenville County, South Carolina in Deed Book 410, page 436.

Grantee to pay 1952 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Her Heirs and Assigns forever.

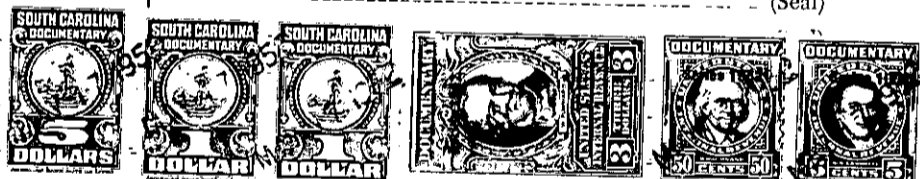

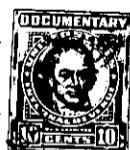
