S. Hwy. No. 276; thence along the western edge of said U. S. Hwy. No. 276, S 29-30 E 100 feet to the beginning corner.

COURSES AND DISTANCES FOR LOT NO. 53: BEGINNING at a point on the western edge of a newly cut 36 foot street, joint corner of lots 53 and 54 on said plat, and running thence S 63-30 W 200 feet to a point, joint corner of lots 53, 54 and 61; thence N 26-15 W 100 feet to a point, joint corner of lots 52, 53 and 61; thence N 63-30 E 200 feet to a point on the western edge of said newly cut street, joint corner of lots 52 and 53; thence along the western edge of said newly cut street, S 26-15 E 100 feet to the beginning corner.
