to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Milton Marshall Word, his heirs and assigns:

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the east side of State Highway # 2, just north of the Town of Simpsonville, being shown and designated as lot # 5 on a plat of property of Subdivision known as "Roland Heights", plat being on record in the Greenville County R. M. C. Office in Plat Book "S" at page 34, and being more fully described as follows:

Beginning at an iron pin on east side of U. S. Highway # 276 (State Highway # 2) corner of lot # 4 and running thence along line of lot # 4 N. 52-16 E. 175 ft. to iron pin, corner with lot 4, 25 and 36; thence along line of lot # 25 N. 35-09 W. 87.5 ft. to iron pin, corner of lot # 6; thence along line of lot # 6, S. 52-16 W. 175 ft. to iron pin on east side of Highway; thence along said Highway S. 35-09 E. 87.5 ft. to the beginning corner.

The above lot is conveyed subject to the Right-of-Way of U. S. Highway 276, and subject to the reservations and restrictions in an instrument affecting all of the property in the mentioned subdivision as recorded in Deed Book 419, page 331, Greenville County R. M. C. Office and reference is here made to that instrument for the terms and conditions of the restrictions and limitations.
