to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Frank W. Garrison:- All our undivided interest in and to a certain tract of land lying and being in Austin Township, Greenville County, State of South Carolina located just north of the Town of Simpsonville on east side of State Highway # 2, adjoining lands of Cannon Gresham, and other lands of Grantors, and containing 3.26 acres more or less according to a survey and plat made by W. J. Riddle, Surveyor on Jan 4, 1952, and having according to said plat the following metes and bounds:-

Beginning at a point in center of a proposed 30 ft. road and on N/E side of County Road that leads off State Highway # 2, and running thence along eastern side of County Road N. 0-19 W. 198.4 ft. to iron pin; thence N. 56-00 E. 743 ft. to iron pin on line of Cannon Gresham; thence along Gresham line S. 22-00 E. 54 ft. to iron pin near branch; thence S. 14-00 E. 127 ft. to iron pin in center of proposed 30 ft. road; thence along center of proposed road, S. 57-00 W. 413 ft. to iron pin; thence still along center of proposed road, S. 56-00 W. 385.4 ft. to the beginning corner.

The above described tract of land is a portion of same tracts conveyed to Minnie C. Garrison by S. A. Curry by deed dated Feb. 17, 1936, recorded in Vol. 184, page 49, R. M. C. Office for Greenville County and it is likewise a portion of same tracts from which Minnie C. Garrison conveyed a 2/5 interest (1/5 each) to Evelyn C. Garrison and Marguerite G. Bates by deed dated Sept. 25, 1937, recorded in Vol. 193, page 156, R. M. C. Office for Greenville County.

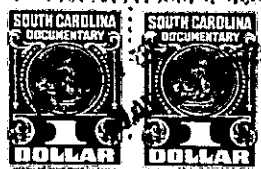
