to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. H. Craig, his heirs and Assigns forever,

All those certain pieces, parcels or lots of land in Greenville Township, Greenville County, state of South Carolina, and located near Saluia Lake, being known and designated as lots 3 & 13 of Block C of the subdivision known as Lakewood, a revised plat of same being recorded in the R. M. C. Office for Greenville County, and according to said plat having the following metes and bounds to-wit:

LOT NO. 3

Beginning at an iron pin on Deborah Lane, the same being the joint corner of lots 2 & 3, and running thence with the joint line of said lots N. 27-24 W. 117.2 feet to an iron pin on DeForest Circle; thence with DeForest Circle N. 55-33 E. 90.5 feet to an iron pin being joint corner of lots 3 & 4; thence with the joint line of said lots S. 27-24 E. 88.8 feet to an iron pin on Deborah Lane; thence with Deborah Lane S. 50-35 W. 12.3 feet to an iron pin; thence continuing with Deborah Lane S. 36-07 W. 80 feet to an iron pin, the beginning corner.

LOT NO. 13

Beginning at an iron pin on DeForest Circle, the corner of lots 13 & 14, and running thence with the line of said lots N. 27-24 W. 139.5 feet to an iron pin near Saluda Lake; thence in a traverse line N. 37-50 E. 98.5 feet to an iron pin being the joint corner of lots 12 & 13; thence with the joint line of said lots S. 27-24 E. 169 feet to an iron pin on DeForest Circle; thence with DeForest Circle S. 55-33 W. 90.5 feet to the beginning corner.

The above two lots are a portion of the property conveyed to grantors by Stanley D. Brown by deed recorded in the R. M. C. Office for Greenville County.
