That I, G. C. Brady in the State aforesaid,  
in consideration of the sum of Five Thousand (\$5000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. L. Anderson

All that piece, parcel and lot of land lying and being in Oaklawn Township, Greenville County, South Carolina, known and designated as tract number 3, on a plat dated March 1931, by G. A. Ellis, Surveyor, of a certain subdivision of land known as the Smith land.

Beginning at an iron pin in the middle of the public road joint corner of tract number 2, thence up said road 12.26 chains to iron pin 1.43 chains to second pin and thence with the middle of said road to Chastain's line 2.35 chains, thence N. 61 1/2 W. 6.50 chains to iron pipe corner, corner the Hugh Prince land, thence S. 37 1/2 W. 28.00 chains to stone W. O., thence S. 74 1/2 W. 2.00 chains to branch, thence with the branch as line 7.00 chains to Saluda River, thence with the meanderings of said river 57.00 chains to maple corner, corner of tract number 2, thence with line of tract number 2 N. 17 1/2 E. 10.50 chains to stone corner, thence N. 49 1/2 E. 10.00 chains to poplar corner, thence N. 65 E. 10.36 chains to stone corner, thence S. 78 1/2 E. 14.70 chains to the beginning corner, and containing 73 acres, more or less, according to survey made by G. A. Ellis, Surveyor, and recorded in Plat Book G, Page 290 in the R. K. C. Office, Greenville County.

This is the same land conveyed to David T. Smith by Thos. Albert Smith by deed recorded in Deed Book 162, Page 3, except for an eight acre tract of land conveyed away by the said Thos. Albert Smith to J. Sullivan Smith and is the identical land conveyed to G. C. Brady by the said Thos. Albert Smith by deed dated Jan. 1, 1944, recorded in Deed Book 293, Page 129, together with such interests as the said G. C. Brady acquired under a quit claim deed from David T. Smith dated April 28, 1948, recorded in Deed Book 344, Page 437, R. K. C. Office, Greenville County.

Grantee is to pay 1952 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

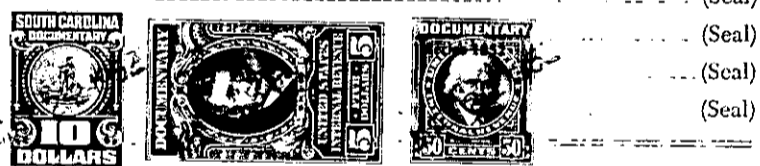
