All the grantor's undivided right, title and interest, in and to all that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, more fully described as follows:

BEGINNING at a point on an alley called Furns Street 164.5 feet from the south side of Sullivan Street and running thence N. 15.0 W. 54.8 feet; thence S. 88.47 E. 113.8 feet; thence N. 0.23 W. 52 feet to corner of Lot 8; thence along the line of that lot N. 30.25 W. 100.1 feet to the beginning corner, being known as Lot No. 9 as shown by plat recorded in Plat Book 3 at page 282.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining,
