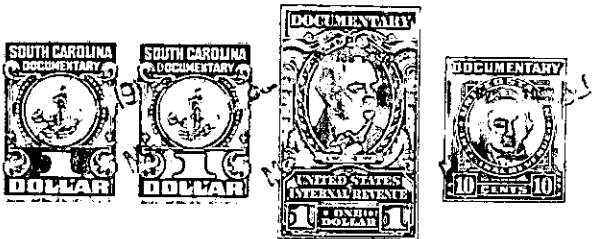
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H.L.Langston and Ray Wilson

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina being known and designated as Lots Nos. 2 and 3 of a Subdivision known as Pinehurst according to a survey made by W. N. Willis, Engineer, October 28, 1948 and recorded in Plat Book "S", at page 77. Reference to said plat is hereby craved for a more accurate description and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint front corner of Lots 1 and 2 on Lee Road and running thence along Lee Road North 73-03 East 122 feet to the joint front corner of Lots 3 and 4; running thence along the joint line of Lots 3 and 4, South 26-48 East 150 feet; running thence South 62-23 West 120 feet; running thence along the joint line of Lots 1 and 2, North 26-48 West 172.5 feet to the point of beginning.
