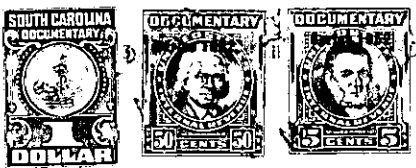

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eugene Carman and Carrie B. Carman, their heirs and assigns, all that piece, parcel, or lot of land lying and being in Saluda Township, Greenville County, and in the state of South Carolina having the following metes and bounds and courses and distances:

BEGINNING on an iron pin on the southwest corner of Eugene Carman lot, previously sold to said Carman, and running thence with said Carman line N. 35.00 W. 114 feet to an iron pin; thence N. 53.15 E. 348 feet to an iron pin; thence S. 47.45 E. 145 feet to a small maple (X on said maple) ; thence S. 1.45 W. 202 feet to a pin, in an old wagon road; thence S. 33.30 W. 53 feet to the northeast corner of above said land; thence with the Carman line N. 35.00 W. 210 feet to an iron pin; thence S. 53.00 W. 210 feet to the beginning corner, containing one acre and forty-four one/hundreds (1.44).

The above described land lies on the northwest side of Cool Springs Church Road and is joined on the south by Tessie J. Ward, on the west by Tessie J. Ward, and on the north by Tessie J. Ward, and on the east by Tessie J. ward, and on the southeast by Eugene Carman.
