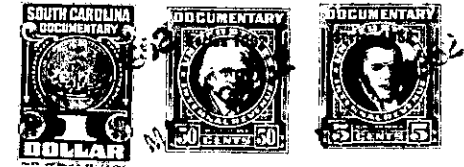
ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 82 of a subdivision known as Section "A", of Englewood Estates, as shown by a Plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville, South Carolina, in Plat Book Y at Page 140, and having the following metes and bounds to-wit:

BEGINNING at an iron pin joint corners of Lots No. 81 and 82 and running thence along the line of said Lot No. 81, S. 87-30 E. 175 feet to iron pin; thence N. 2-30 E. 100 feet to iron pin at back corner of Lot No. 83; thence along the line of said Lot No. 83, N. 87-30 W. 175 feet to iron pin on Overlook Drive; thence running with Overlook Drive S. 2-30 W. 100 feet to point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.
