to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John L. Vaughn, his heirs and assigns:

All my undivided one-half interest in and to all that certain piece, parcel or lot of land lying and being on the Southerly side of Long Forest Drive, near the City of Greenville, South Carolina, being shown as Lot No. 41 on the plat of the property of Nabers and ... as recorded in the R.D. Office for Greenville County, S. C. in Plat Book "0", page 195, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the Southerly side of Long Forest Drive at a point 463.3 feet West of the Southwesterly corner of the intersection of Long Forest Drive and Old Sumner Road, said pin being also the joint front corner of Lots Nos. 41 and 42, and running thence along the joint line of said lots S 6-25 W 201.5 feet to an iron pin; thence N 81-21 W 174. feet to an iron pin in the center of a three foot strip reserved as an easement for a ditch, said pin also being the joint rear corner of Lots Nos. 40 and 41; thence along the center of said three foot strip, the common line of Lots Nos. 40 and 41, N 0-08 E 200.7 feet to an iron pin on the Southerly side of Long Forest Drive; thence along the Southerly side of Long Forest Drive S 12-20 E 196.5 feet to the point of beginning.
