to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, namely: C. C. Batson, his heirs and assigns forever, all those two certain pieces, parcels, tracts or lots of land situate in Saluda Township, Greenville County, State of South Carolina, more particularly described as follows:

FIRST TRACT : Beginning at a point in the middle of Highway No. 11, about 30 feet opposite a big white oak, and running thence S. 70 W. 150 feet to bend in road; thence N. 80 W. 60 feet to a point in middle of road (stake on bank); thence N. 25 1/2 W. 210 feet to stake; thence N. 79 E. 210 feet to stake; thence S. 25 1/2 E. 210 feet by white oak and on to center of road, the beginning corner, and containing one acre, more or less, and being the same land conveyed to me by deed from W. L. Edwards et al., and recorded in the R. M. C. Office for said county in Deed Book 281 at page 402; and, also.,

SECOND TRACT : Beginning at a chestnut oak and running thence S. 73 1/2 W. 13.95 chains to a black gum; thence S. 36 1/2 W. 10.30 chains to a stone; thence S. 87 1/2 E. 22.25 chains to a stone; thence S. 18 1/2 W. 11.63 chains to a sourwood (down); thence S. 87 1/2 E. 36.30 chains to a stake; thence N. 9 W. 15.50 chains to a stake in the branch; thence up the meanders of said branch 34 chains to a stake in branch on William Turner's line (now Arkie Turner); thence S. 27 W. 8.54 chains to the beginning chestnut oak and containing 85 acres, more or less, and being the same land conveyed to me by deed from Theron E. Barton et al., and recorded in the R. M. C. Office aforesaid in Deed Book 281 at page 411.
