That I, Nell Rosamond Farr, herein called grantor in the State aforesaid, in consideration of the sum of Exchange of lots DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Herbert Perry Rosamond, herein called grantee, Lot 34 located on the north-eastern side of Rodney Avenue as shown on plat of property of J. P. Rosamond by Dalton E. Neves, dated April 1931, recorded in Plat Book II at Page 186, from which plat the following description is taken:

BEGINNING at the joint front corner of Lots 34 and 35 on the northeastern edge of Rodney Avenue, which point is 305' northwest of the northeastern intersection of Rodney Avenue and an unnamed street, and running thence the joint line between Lots 34 and 35, N. 25-15 E. 100' to their joint rear corner with Lots 18 and 19; thence the joint rear line between Lots 19 and 34, N. 04-45 W. 50' to the joint rear corner between Lots 19 and 20 and 33 and 34; thence the joint line between Lots 33 and 34, S. 25-15 W. 160' to their joint front corner on the northeastern side of Rodney Avenue; thence the northeastern side of Rodney Avenue S. 04-4; E. 60' to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
