J. C. Cooley his Heirs and Assigns forever: My whole and entire undivided interest in and to -

All that piece, parcel or tract of land lying, being and situate in the County and State aforesaid and containing 15.53 acres, more or less, according to a plat and survey made by J. C. Hill, Surveyor, on March 21, 1951 and described according to said as follows:

Beginning at an iron pin, corner on line of Lusk property and running thence S. 21-45 W. 303.6; thence with the Lusk line N. 65 W. 1511 feet to a stone, said stone measuring a distance of 700 feet from Saluda River; thence N. 10-50 E along line of N. P. Cooley 586 feet to an iron pin; thence N. 54 E. 491.3 feet to a stake in edge of road; thence S. 5-30 W. 759 feet to an iron pin; thence S. 65 E. 1135.2 feet to an iron pin, the point of beginning, and bounded by Lusk property N. P. Cooley and others.
