Know All Men by These Presents:

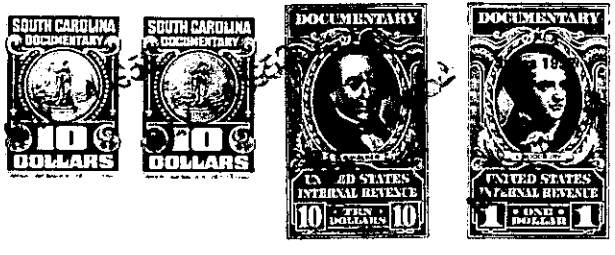
That I, C. J. Futrell in the State aforesaid,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known as lot no. 35 of Block "B" of Cagle Park as shown on plat recorded in Plat Book "C", page 238 and described as follows:
