Know All Men by These Presents:

That I, Robert J. Edwards in the State aforesaid, in consideration of the sum of Fifteen Hundred and No/100 (\$1500.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said N. L. Langston, his heirs and assigns forever:

All that lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Southeast side of Super Highway No. 29, being shown as lot 205, on a plat of property of Robert J. Edwards, made by Dalton Neves in May 1951, and described as follows:

BEGINNING at an iron pin on the Southeast side of the right-of-way of U. S. Highway No. 29, joint front corner of lots 204 and 205, and running thence with line of lot 204, S. 47 E. 325 feet to iron pin; thence N. 43 E. 100 feet to iron pin at rear corner of lot 206; thence with line of lot 206, N. 47 W. 325 feet to an iron pin on right-of-way of U. S. Highway No. 29; thence with the Southeast side of said right-of-way, S. 43 W. 100 feet to the point of beginning.

It is understood that this conveyance is made subject to the following restrictions, which are expressly made a part of the consideration thereof, and that the same are for the benefit of the grantor, grantee and all other persons owning lots shown on said plat above mentioned:

- (1) Said lot shall be used exclusively for residential purposes.
(2) No dwelling shall be erected on said lot containing less than 1200 square feet of floor space, exclusive of porches and breezeways.
(3) No temporary buildings shall be used for residential purposes, nor shall any garage apartment be constructed on said lot.
(4) The outer or exterior walls of any residential dwelling shall be of material other than concrete blocks.
(5) No building of any kind, or residence shall be constructed nearer than 50 feet from the front line of said lot.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

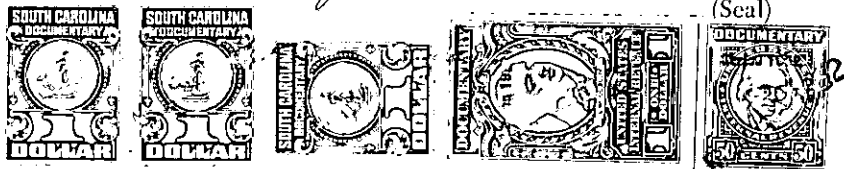
