Know All Men by These Presents:

That I, Lucy L. Hindman, herein called grantor in the State aforesaid, in consideration of the sum of Three-thousand six-hundred (\$3600.00) and no/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. H. Mauldin, herein called grantee, four lots located on the western side of Townes Street Extn. and shown as Lots 1, 2, 3 and 4, Block H, of plat by W. J. Riddle of Highland Terrace, recorded in Plat Book K, Pages 120-122. From this plat the following description is taken:

BEGINNING at the joint corner of Lots 4 and 5 on the western edge of Townes St. Extn., and running thence N. 16-44 E. across Lots 4, 3, 2 and 1, 200' to the northeastern front corner of Lot 1; thence the northern line of Lot 1, N. 73-16 E. 150' to its rear corner; thence S. 16-44 W. along the rear line of Lots 1, 2, 3 and 4, 200' to the joint rear corner of Lots 4 and 5; thence the joint line between these lots S. 73-16 E. 150' to their joint front corner on the western edge of Townes St. Extn., the beginning corner.

The above lots are shown on County Tax Map, District 7-10, Map 170, Block 3, as Lots 7, 10, 11 and 12.

Taxes for 1952 have been apportioned and are to be paid by the grantee.
