M. C. Office for Greenville County in Plat Book T, Page 261 and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the southern side of Marshall Court, joint front corner of lots numbers 5 and 6 which iron pin is situate approximately 641.6 feet from the intersection of Marshall Court and Brookside Way and running thence along the line of lot N. 6, S. 25-14 E. 110 feet to an iron pin joint corner lots 5 and 6; thence S 68-15 W 243.3 feet to an iron pin; thence N 25-45 W 137.6 feet to an iron pin joint corner lots 4 and 5; thence along the line of lot No. 4, N 64-46 E 204.1 feet to an iron pin joint front corner of lots 4 and 5; thence along the curved portion of Marshall Court, the chord of which is S 66-33 E, 60 feet to the point of beginning.

Being the same property conveyed to grantor by G. A. Ruff by deed recorded in R. M. C. Office for Greenville County in Deed Book 408, Page 324. The above described property is subject to the restrictive covenants of record in Deed Book 418, Page 183.

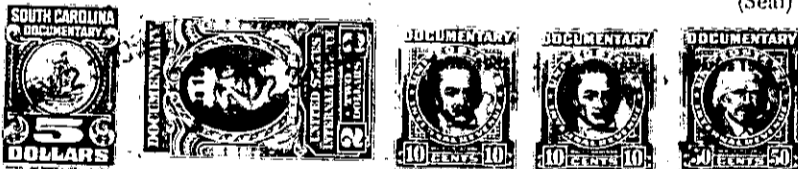
