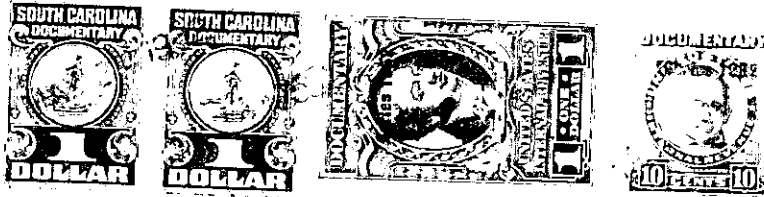

KNOW ALL MEN BY THESE PRESENTS. That I, Ben F. Perry, of the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars (\$10.00.) and other valuable considerations, to me in hand paid at and before the sealing of these presents by Robert Grady Coleman, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert Grady Coleman,

all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Merrilat Avenue between Earnshaw Avenue and Callahan Avenue, in Sans Souci Heights, a Sub-Division on the New Buncombe Road about four miles north of the City of Greenville, said lot being known as lot numbered seventy-three (73) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "AA" at page 59, which Plat is hereby referred to and made a part hereof, and said lot has the following lines, courses and distances:-

Beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Merrilat Avenue, said pin being the joint front corner of lots seventy-three (73) and seventy-three "A" (73-A); and running thence along the northern edge of said sidewalk, N. 77-38 W., sixty (60) feet, to an iron pin, joint front corner of lots seventy-two (72) and seventy-three (73); thence along the eastern line of lot seventy-two & 2), N. 11-42 E., eighty-nine and two tenths (89.2) feet to an iron pin, joint rear corner of said lots seventy-two (72) and seventy-three (73); thence along the rear line of lot sixty-eight (68), S. 77-38 E., sixty (60) feet, to an iron pin, joint rear corner of lots seventy-three (73) and seventy-three "A" (73-A); thence along the western line of lot seventy-three "A" (73-A) S. 11-42 W., eighty-nine and two tenths (89.2) feet, to an iron pin, the beginning corner.

This property is sold subject to the restrictive covenants applicable to Sans Souci Heights, recommended by the Federal Housing Administration, and recorded by the owner in the R. M. C. Office for Greenville County in Book 425, at page 500, and the same is hereby referred to and made a part hereof.

The above described land is a part of the same conveyed to me by Frances T. Tindal, et al., and E. Inman, Master, on the third day of January, 19 50, deed recorded in office Register of Mesne Conveyance for Greenville County, in Book 399 Pages 236 and 215.
